# Introduction - ARISE-US Annual Report for 2023

- ARISE-US is the US Network of ARISE, established by the UN DRR to build public private collaboration globally in disaster risk reduction (DRR).
- These slides summarize ARISE-US' activities in 2023 and provide a forward look for 2024.
- They detail our many successes in 2023, and also, in a spirit of honesty, some “less-than-successes”, at least so far – they may yet become successes in 2024.
  - We operate a portfolio approach, launching multiple initiatives expecting that many will succeed, some will run slower than intended but succeed eventually, and some will fail. Provided that the portfolio as a whole is moving forward, that is acceptable.
- Not shown here, because there are just too many to list, are the introductions and collaborations we have fostered between ARISE-US members, and between our organization and other organizations in the public and private sectors, in areas as diverse as flood management, wildfire risk reduction, carbon accounting protocols, resilience standards and Reverse Trade Missions. We regard these convergences as a critical benefit of the ARISE-US network.

# ARISE-US Mentorship Program

<b>Purpose</b>	To provide training and leadership opportunities to students, early career, transitioning, and emerging disaster resilience professionals. Mentees are advised by private sector mentors on capstone projects and gain hands-on experience by contributing to ongoing ARISE-US initiatives.

## 2024 – Funding and Legal Entity

- In 2024 we plan to enter into a fiscal sponsorship arrangement with a professional NGO management organization. This will give us the same tax advantages to offer donors as a 501(c)(3) non profit.
- We have commenced seeking funding in 2024 for:
  - Further mentorships and an Equity toolkit;
  - SME Hub;
  - Further developments to the Wildfire toolkit;
  - Biennial global survey of DRR governance and readiness;
  - A professional administration for ARISE-US.
- We will approach grant giving organizations (foundations, NGOs, corporations) in the first instance.
- We may also initiate crowdfunding and in-kind donation schemes. (We are not allowed under the terms of our charter from the UN, to charge for membership).

# More on ARISE

- UNDRR-led network of private sector entities which currently comprises:
  - ✓ **30** national networks.
  - ✓ Over **400** member companies.
  - ✓ Nearly **850** members in the shared community cloud
  - ✓ Members from private and public sectors.
- Members voluntarily commit to support and implement the [Sendai Framework Disaster Risk Reduction 2015 – 2030](#), aligned with the 2030 Agenda for Sustainable Development and its Sustainable Development Goals (SDGs), Paris Climate Agreement, New Urban Agenda and Agenda for Humanity.

- The Four Priorities of the Sendai Framework:
  1. Understanding disaster risk.
  2. Strengthening disaster risk governance to manage disaster risk.
  3. Investing in disaster risk reduction for resilience.
  4. Enhancing disaster preparedness for effective response and to “Build Back Better” in recovery, rehabilitation and reconstruction.



# Our Modus Operandi

- Our modus operandi is “doing well by doing good”.
- We create projects, pro bono, that make a meaningful contribution to disaster risk reduction in some way.
  - For example, our [City Disaster Risk Reduction Scorecard](#) has now been used by well over 400 cities globally.
- Our impact helps to expand our network of members, which in turn increases the number of projects we can consider.
- Our members (and anyone else) are then at liberty to create for-profit derivative works from our pro bono activities.
  - In so doing, we help turn the “overhead” of disaster risk reduction into an economically positive activity.

# ARISE Membership Requirements

- ARISE is open to all private sector companies, other stakeholders and private sector networks independent from sector, company size or revenue, with the exception of companies that are:
  - ✓ Subject to a UN sanction.
  - ✓ Listed on the UN Ineligible Vendors List for ethical reasons.
  - ✓ Listed in the [Database A/HRC/43/71\\*](#) of business enterprises involved in the activities
  - ✓ Derive revenue from controversial weapons, including the production, sale and/or transfer of antipersonnel landmines or cluster bombs.
  - ✓ Derive revenue from the production and/or manufacturing of tobacco.
- Follow good governance rules, notably maintaining integrity and independence of each partner, commitment to partnership obligations, transparency, accountability and sound financial management.
- ARISE Networks must adhere to the 10 Principles of the UN Global Compact.





# ARISE Application Requirements

ARISE applicants are required to submit 3 documents:

1. A completed Application Form.
2. Valid Proof of Legal Registration.
3. Signed Statement of Commitment.
